A. Binomial Option Pricing in One Period 40 points


Riskless bond (interest rate is 10%):

European call with a strike price of 114:



1. What are the payoffs of the European call in the up and down states?

2. What are the risk-neutral probabilities for the two states tomorrow?

3. What is the price of the European call today?

4. Would the value of the corresponding American call be the same?

B. Concepts (multiple choice) 20 points

2. In risk-neutral probabilities, what is the mean percentage change in a stock price?

3. In actual probabilities, what is the mean percentage change in a futures price?

- b. Risk premium

5. Suppose we expect the price of ABC stock to be very volatile but we don't have a view on the direction it will move. Which of the following is the best strategy?

C. Binomial futures option pricing 40 points

The short riskless interest rate is 25% per period. The two-period corn futures price is \$150 today and will go up or down by \$50 each period, with risk-neutral probabilities 1/2 and 1/2. Consider a European futures call option with an exercise price of \$125 maturing two periods from now.

1. What are futures prices in the tree?

2. What are the call payoffs at maturity?

3. What is the price of the futures call option at each node in the tree?

4. (conceptual question) Why aren't the risk-neutral probabilities 1/2 and 1/2 the same as what would be given by the familiar formulas  $\pi_u = (r - d)/(u - d)$  and  $\pi_d = (u - r)/(u - d)$  where u and d are computed from the futures price tree?

## D. Bonus question (short answer) 20 points

In the Black-Scholes model, the call option price is always positive before maturity if the volatility is positive. However, in the binomial model the call option price can be zero before maturity even if the volatility is positive. Why are the two models different?

## **Useful Formulas**

Binomial model: if the stock has up and down factors u and d and one plus the riskfree rate is r, then the risk-neutral probabilities are

$$\pi_u = \frac{r-d}{u-d}$$
$$\pi_d = \frac{u-r}{u-d}$$

and the one-period option valuation is

$$\operatorname{price} = \frac{1}{r} \left( \pi_u V_u + \pi_d V_d \right).$$

The Black-Scholes call price is

$$C(S,T) = SN(x_1) - BN(x_2),$$

where S is the stock price,  $N(\cdot)$  is the cumulative normal distribution function, T is time-to-maturity, B is the bond price  $Xe^{-r_fT}$ ,  $r_f$  is the continuouslycompounded riskfree rate,  $\sigma$  is the standard deviation of stock returns,

$$x_1 = \frac{\log(S/B)}{\sigma\sqrt{T}} + \frac{1}{2}\sigma\sqrt{T}$$

and

$$x_2 = \frac{\log(S/B)}{\sigma\sqrt{T}} - \frac{1}{2}\sigma\sqrt{T}.$$

Note that  $\log(\cdot)$  is the natural logorithm.

The Black-Scholes call price can be approximated by

$$\frac{S-B}{2} + .4\frac{S+B}{2}\sigma\sqrt{T}.$$

The put-call parity formula is

$$B + C = S + P.$$
